Fox Islands Outing Club 2025-26 Liability Waiver

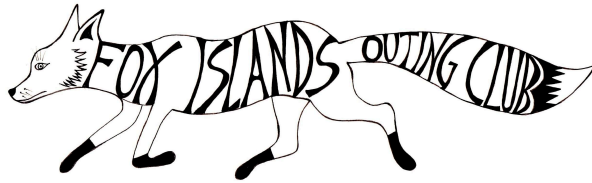
